Seller warrants that the puppy is free of communicable diseases, is in good health, and is of stable temperament having been well socialized. Puppy will have received his/her first set of vaccinations, and worming. Buyer is obligated to have the puppy examined at Buyer's expense by a licensed veterinarian to verify general health within 72 hours from the date of pick up, delivery and/or shipment: \_\_\_\_\_\_\_\_Failure on the part of the Buyer to have the Puppy's health verified will result in all warranties being canceled/nulled/void. Seller accepts no liability for any communicable diseases after 24 hours from when the puppy leaves the possession of Seller. If

puppy/dog does not pass a general health exam, Buyer agrees to notify breeder/seller via email or phone within 24 hours of veterinary notification and provide a copy of the original signed licensed veterinary statement of health. Minor, treatable problems, such as, diarrhea, coccidiosis, parasites, giardia, etc. Are common problems in puppies. Especially under the stress of new circumstances, and will not be covered by this warranty, although every effort is made to prevent this.

SPAY/NEUTER AGREEMENT: This puppy is being sold by Breeder and purchased by
Buyer(s) as a pet-quality/companion dog only. Buyer(s) is obligated to spay/neuter the dog as
described herein. Buyer(s) agree that the dog will not produce a litter of puppies, either as
purposely bred or by accidental breeding. Buyer(s) agree that this dog shall be spayed/neutered
by(equivalent to 6 months of age) and evidence of said spay/neuter is
required to be provided to Breeder in writing within seven (7) days of said procedure. Proof of
spay/neuter must be on veterinary hospital letterhead, showing the puppy's name, date of birth,
and microchip number (if applicable).
PURCHASE PRICE. The purchase price of \$("Purchase Price") is agreed with
the balance due in full upon Buyer's pickup of the puppy/dog. All payments due under this
Agreement shall be made in US Dollars and paid to Breeder via Good Dog or in cash at the time
of pickup, before the puppy leaves the care of Breeder.

**PET INSURANCE**: Within 24 hours of receiving the dog, Buyer(s) will be provided with a certificate for a free 30-day trial of pet insurance with Trupanion. The Buyer(s) shall promptly activate the insurance and provide proof of activation to Breeder before the date of possession. Continued service beyond the 30-day free trial is *not* required. BREEDER SHALL NOT BE RESPONSIBLE FOR ANY MEDICAL EXPENSES THAT BUYER(S) INCUR.

**TWO-YEAR HEALTH GUARANTEE:** Even though Breeder has worked diligently to carefully monitor the dog's development and has performed health testing to help reduce risk of disease and conditions that negatively impact health and quality of life, Buyer(s) understands that dogs are living beings and that these factors alone do not guarantee that the dog will never have any illness or any health condition. Because there are other factors that affect a dog's development, (i.e., *nutrition, environment, activity levels, trauma etc.*), Breeder has developed this guaranteed process. BREEDER SHALL NOT BE RESPONSIBLE FOR ANY MEDICAL EXPENSES THAT BUYER(S) INCUR.

#### 2. GUARANTEE INCLUSIONS:

a. **Eye Defects.** Genetic defects of the eye causing progressive blindness and/or requiring surgery to prevent blindness, as diagnosed by a board-certified veterinary ophthalmologist. Also included is a prolapsed gland of the nictations (cherry eye) and entropion.

- b. Cardiac and Liver Disorders. Cardiac and liver disorders of clearly genetic origin that require surgery or that, after treatment, is life-threatening or diminishes the dog's quality of life. Screening exams as part of a wellness check or for the purpose of OFA certification are both considered screening exams and do require further testing for a diagnosis by a board-certified canine cardiologist or licensed veterinarian specialist.
- c. Health, Color, Coat, and Trait Testing. The Breeder has tested the dogs' parents for most of the currently recommended health tests right to the respective poodle variety by the parent club (Poodle Club of America) per the American Kennel Club (AKC). Should Buyer(s) choose to perform any additional testing or retesting not specifically included in any testing results of the dogs' parents and/or the dog attached hereto and incorporated herein (*including health*, *breed composition*, *color*, *coat*, *trait*, *etc.*), the Breeder specifically excludes the product of those results from this Agreement, and the Buyer(s) agrees to not hold the Breeder responsible in any way. This includes any testing result from any testing company showing the dog has none, one or both genes of any health gene, color, coat, or any trait, etc.) specifically including CDDY-IVDD as this genetic marker is "set" in the smaller poodle varieties (85-90% of all toy and miniature poodles).
- d. **Patellar Luxation.** patellar luxation requiring surgical intervention. Dogs that are at any point overweight or that incur injury to bones or joints from Severe patellar luxation is defined as over-exercise, trauma, or may have an environmental link are explicitly excluded from guarantee of severe patellar luxation. All requests and submission of documentation shall be given to Breeder by Buyer(s) within seven (7) days of diagnosis. Buyer(s) must show proof of healthy weight by having their veterinarian evaluate the dog's body condition score at all veterinary visits.
- e. **Hip Dysplasia.** Hip dysplasia is multigenic and multifactorial. Moreover, dogs can have signs of osteoarthritis or hip dysplasia on an X-ray, but those dogs may never have clinical signs of either condition even if they are produced by parents with no radiological or clinical signs. This guarantee only covers severe clinical hip dysplasia within the stated period providing the dog has not been overweight, exposed to unhealthy environmental conditions, trauma, or had any physical injury or issues which cause is unknown or may have an environmental link. Since current veterinary science shows that dysplasia/osteoarthritis is more a product of nutrition and environment than genetics, dogs that are at any point overweight or that incur injury to bones or joints from over-exercise or exposure to improper or harsh environment are explicitly excluded from guarantee of hip or elbow dysplasia. All guaranteed requests and submission of documentation shall be given to Breeder by Buyer(s) within seven (7) days of diagnosis.

At a minimum, radiographic evidence of hip-dysplasia-associated osteoarthritis must be provided to be considered severe dysplasia along with evidence of severe clinical symptoms, with a second opinion provided at Buyer(s)'s expense by a Breeder- approved veterinarian or certification authority (i.e., OFA or Penn HIP). Buyer(s) must show proof of healthy weight by having their veterinarian evaluate the dog's body condition score at all veterinary visits.

f. **Death.** If the dog dies, and Buyer(s) suspects a clearly genetic origin or other condition guaranteed within this Agreement, Buyer(s) must have a necropsy performed by a licensed veterinarian at Buyer(s)'s expense. Buyer(s) must include copies of diagnosis and all treatment documentation to Breeder. Breeder reserves the right to request a second opinion from a veterinarian of their choice in the local area of Buyer(s) or via phone consult with a veterinarian in any location and grants permission to Breeder and Breeder's veterinarian to consult with all professionals treating the dog. Should any travel or shipping fees become necessary, Buyer (s) shall bear those costs.

Should a guaranteed inclusion event occur within this guarantee period, the dog must first be spayed or neutered. Evidence of the spay/neuter is required to be provided to Breeder in writing within seven (7) days of said procedure. Proof of spay/neuter must be on veterinary letterhead, showing the dog's name, date of birth, and microchip number. After that time, Buyer(s) may choose to:

- I. Keep the dog and receive a dog valued up to the adoption price of the dog from Breeder.
- II. Rehome the dog to a good, suitable home, then receive a dog valued up to the adoption price of the dog from Breeder.
- III. Not keep the dog or is unable or can't rehome after a considerable effort, Buyer(s) can return the dog to Breeder and shall transfer of ownership of the dog's kennel club registration papers (if any), immunization and medical records, microchip registration, etc. back to Breeder. All costs associated with returning the dog shall be borne by Buyer(s). Buyer(s) then can receive f dog valued up to the adoption price of the dog from Breeder and that dog's transportation costs shall also be borne by Buyer(s).

Should a guaranteed inclusion event result in death of the dog within this guarantee period and all requirements have been satisfied contained within this Agreement as contained in paragraph If then Buyer(s) may choose to:

- 1. Receive a dog valued up to the adoption price of the dog from Breeder. Any of the dog's transportation costs shall be born by Buyer(s).
- 2. Forfeit any remedy(s) available as contained within this Agreement and not receive another dog from Breeder.

THERE SHALL BE NO CASH REFUNDS FROM BREEDER FOR ANY COSTS INCURRED BY BUYER(S) NOR FOR ANY COSTS ASSOCIATED WITH THE ADOPTION PRICE OF THE DOG OR "REPLACEMENT" DOG.

#### **3.GUARANTEE EXCLUSIONS:**

- **a.** Surgical Procedures. Any routine surgical procedure costs including injury or death from any routine procedure.
- b. Conditions & Minor Flaws. Common dog parasites brought on by the stress of changing environment, shipping, or motion sickness. Stress can ignite opportunistic parasites such as coccidia (dormant in most live animals), giardia (also dormant in most live animals), and occasionally upper respiratory infections, etc. Also excluded are viral illnesses, infections, upper respiratory conditions, ear mites or infections, skin issues including mites, fleas or ticks, tissue issues, malocclusions, allergies, herniations, open fontanels, cryptorchidism, low grade heart murmur (not requiring surgery) low-grade luxting patellas (not requiring surgery) low grade luxating patellas (not requiring surgery) or non-life threating portosystemic shunt. Non-life-threatening eye, skin, tissue, allergies, herniations, cryptorchidism, malocclusions, mild luxating patellas and open fontanels.
- **c.** Illnesses Of Unknown Origin. Any illness due to the ingestion of foreign objects, food, plants, chemicals or other items, physical injury, or issues which cause is unknown or may have an environmental link or illnesses from unknown causes including, but not limited to, cancerous growths.
- **d.** Characteristics. Because there are other actors that affect a dog's development, (i.e., nutrition, environment, trauma etc.), Breeder cannot guarantee size, color, conformation, or temperament of any dog beyond the date of this Agreement.
- e. Dewclaws & Tail. Breeder states that dewclaws have been removed by a licensed veterinarian but cannot guarantee they will not re-grow and excludes any veterinarian charges for removal of dewclaws or docking of the dog's tail.
- **f. Trauma & Environment.** Health issues such as luxating patellas and hip dysplasia arising from trauma, environment, or failure to maintain general health care of the dog, including allowing the dog to become overweight (overweight is defined as body condition score over 5 on a scale of 9). Also not included is injury to joints
- **g. Hypoglycemia.** Breeder will never accept any liability for any losses of any nature because of this condition. *Any signs of depression, lethargy, lack of appetite or desire to drink water, diarrhea (particularly with blood and/or mucous), or vomiting must be treated by your veterinarian immediately!*

**PREVENTATIVE HEALTH:** Buyer(s) agrees to keep the dog in good physical condition with regularly scheduled health visits with your veterinarian for the proper ongoing health proper for your area, as recommended by your veterinarian. Buyer(s) further agrees to provide proper shelter, regular grooming, exercise, fresh water, high-quality dog food, treats, pet care products, and nutritional supplements (we highly recommend <u>NuVet</u> Supplements) appropriate for your dog.

**REHOME OR RETURN OF DOG:** We don't wish for any puppy to be sold or given to any pet shop, animal shelter, rescue, research laboratory or other similar facility. In case of legal action necessary to enforce the obligations on the Buyer(s) by the Breeder the Buyer(s) shall be responsible for all reasonable expenses of such enforcement including Breeder's necessary attorney's fees, court coasts, and travel fees.

In the event Breeder ceases breeding activities, this Agreement will be terminated and Buyer(s) releases Breeder from all claims.
